

Application for a Visitor's Regulated Weapons Permit

Please complete in BLOCK CAPITALS and in black ink.

This application may be completed by a person resident in the Isle of Man on behalf of a visitor to the Isle of Man. The person making the application is referred to in this form as the sponsor. The completed form should be sent to:

Please read the following notes carefully before completing the form:

- 1 This form should be used for application by or on behalf of visitors wishing to possess a regulated weapon whilst in the Isle of Man.
- 2 A regulated weapon is defined as a shotgun, an air weapon or a cross-bow.
- 3 A shotgun is defined as:
 - a smooth bore gun (not being an air gun) which -
 - a) has a barrel not less than 24 inches in length and does not have any barrel with a bore exceeding 2 inches in diameter:
 - b) either has no magazine or has a non-detachable magazine incapable of holding more than two cartridges; and
 - c) is not a revolver gun.
- 4 An air weapon is defined as:
 - a weapon where the propulsion is caused by or derived from the use of gas or air.

Note - smooth bore guns other than those defined under 3 or 4 above require a Firearms Certificate.

- 5 A cross-bow is defined as:
 - a cross-bow with a draw weight of 1.4 kilograms or more.
- 6 The sponsor must complete **Parts A** and **D** of **Form 2**. **Parts B** and **C** may be completed by either the sponsor or the visitor(s). **Part C** is to be completed where a group visit is to take place.

It is an offence for any person to knowingly make a false statement for the purpose of procuring the grant of a permit.
